#### Safeguarding in the Diocese of Kildare & Leighlin

The Diocese works in co-operation with the statutory authorities and the National Board for Safeguarding Children in the Catholic Church in Ireland (NBSCCCI).

- 2005 The Kildare & Leighlin Safeguarding Committee was formed.
- 2009 National Policy for Safeguarding Children was adopted by the Diocese of Kildare & Leighlin.
- 2010 The HSE conducted an audit of Child Sexual Abuse incidents within the Diocese of Kildare & Leighlin
- 2012 The NBSCCCI conducted a review of Safeguarding Practice in the Diocese of Kildare & Leighlin
- 2016 The NBSCCCI published an updated policy for Safeguarding Children. This
  policy was adopted by Bishop Denis Nulty for the Diocese of Kildare & Leighlin.

#### **Our Safeguarding Structure**

#### **Designated Liaison Person (DLP)**

The DLP is always available to hear safeguarding concerns and is responsible for reporting such concerns to the civil authorities

**Parish Safeguarding Representatives** 149 Parish safeguarding representatives help Parish Priests across our 56 parishes

#### **Reviewing our Practice**

Parish Safeguarding Representatives alongside the Parish Priests report on their safeguarding practice annually in the form of an audit.

Parish Support Visits are now a requirement of the NBSCCCI. The purpose is to support parishes to improve Safeguarding practice. To arrange a visit for your parish contact the Safeguarding Co-Ordinator on 086-1710643.

Parish Audits are reviewed by the Diocesan Safeguarding Committee and action areas are addressed in the safeguarding plan for the coming year.

### **Co-operating with Civil Authorities**

The Diocese works closely with Tusla, Child and Family Agency and the Gardai to ensure the safety of children. Interagency meetings take place regularly, ensuring appropriate information exchange and effective case management takes place.

Any allegation of child abuse received by the Diocese is referred without delay to the appropriate civil authorities, to whom any information or documentation in the possession of the Diocese is made available.

In 2010 the Health Service Executive reported on the Audit of Kildare & Leighlin Diocesan allegations of sexual abuse.

In 2012 the Diocesan safeguarding files were audited by the staff of the National Board for the Safeguarding of Children in the Catholic Church in Ireland. Information in relation to the review is available to view on the National Board website.

#### **Can We Help You?**

The Diocese continues to develop its service for responding to and managing allegations of abuse most recently with the establishment of the Safeguarding office in January 2019. This centralised, professional service will enhance the good safeguarding work done previously and support future training and development.
