Update from the Safeguarding Office

Safeguarding Evening at Mt St. Anne's

Bishop Nulty & the diocesan safeguarding team was delighted to host a safeguarding information evening in Mt St. Anne's on Thursday 25th January 2024 for all local safeguarding reps and parish priests.

Dr. Jessie Rogers of Maynooth University spoke to the topic of "Theology of Safeguarding", highlighting how scripture tells us - Children need to be at the centre of the Church.

Youth Leaders from the Diocese also gave an informative and motivating presentation on "Creating Youth Participation".

Thank you to all who attended and enriched the evening with great engagement and discussion.



Review by the National Board for Safeguarding of Children in the Catholic Church in Ireland (NBSCCCI)

Safeguarding Practices within the Catholic Church are reviewed independently, by the NBSCCCI. You will remember that the Diocese of Kildare & Leighlin was reviewed in December 2022 and their final report subsequently released and published on the Diocesan website in 2023.

Main conclusions from the report;

- From meetings and discussions with Bishop Nulty, his safeguarding team and the Local Safeguarding Representatives in the parishes, the Reviewer is

satisfied with the safeguarding arrangements in Kildare and Leighlin Diocese, and with its levels of compliance with the National Board safeguarding children standards.

- There is evidence of a strong commitment and dedication by everyone to creating and sustaining a safe environment for all those involved in Church ministry. This is a diocese that strives to reach out to and engage with its parishioners and local communities.

- The Diocese of Kildare and Leighlin is in a good place to take these developments forward.
- Under Bishop Nulty's leadership, and with the support of those around him, an open culture has been fostered that is focused on learning and improvement, so that everyone in the diocese can feel safe, valued, and cared for.



Annual Parish Audits

- The Local Safeguarding Rep in each of the 56 parishes carry out an annual safeguarding self-audit on behalf of the parish Priest.
- The audits are collated by the Director of Safeguarding who compiles a report for the Diocesan Safeguarding Committee.
- This information is valuable to the Diocesan Safeguarding Committee when formulating their three-year strategic plan.
- It also helps advise the committee on how best to re-engage young families, children, and young people with the Church.
- Parish Self-Audits for 2023 are now in progress.

Safeguarding Training

Kathleen Sherry kindly completed the training schedule for 2023 along with the Diocesan Safeguarding Trainers with the last events being held in November 2023 in Newbridge Parish Centre and in Portlaoise Parish Centre.

A training schedule for Spring 2024 is currently being drafted by Ailish Higgins. Feedback from the parish self-audits will be vital in establishing the training needs of parishes going forward.
